Cash flow boost

- Receive tax-free payments up to \$100k
- 1st tranche payment equal to 100% of employee's withholding tax
- 2nd tranche payment equal to 1st tranche amount
- Employers not required to withhold tax will receive \$20k minium payment

JobKeeper Payments

- Wage subsidy of \$1,500 per employee per fortnight
- Subject to employee eligibility criteria
- For businesses whose turnover is reduced by 30% or more

50% subsidy apprentice wages

- Wage subsidy of 50% of apprentice or trainee wages for up to 9 mths fron Jan 2020 to Sep 2020.
- Maximum benefit \$21k per apprentice or trainee

Instant Asset Write Off \$150k

- <500m turnover
- Asset must be installed and ready for use by 30 June 2020
- Only applies until 30 June 2020

Accelerated Depreciation

- < 500m turnover
- Not using simplified depreciation rule
- 50% deduction of the cost
- Existing depreciation rules apply to the balance
- Asset must be installed and ready for use by 30 June 2021

Government Backed Loans

- Government will guarantee 50% of unsecured loans up to \$250k
- Available to businesses with a turnover < \$50 million
- Financial institutions will be providing the products

VIC

VIC Payroll Tax

- Taxable Wages < \$3m
- · Payroll tax refund of first 3 quarters
- Last quarter no payment required

Business Support Fund

- Up to \$10k per business
- Employ people
- Business subject to closure or highly impacted by shutdown
- Turnover > \$75k
- Payroll < \$650k
- Held an ABN and was in business on 16 Mar 2020

Land Tax Deferral

- Deferral of their 2020 land tax payment until after 31 December 2020
- Land owners with at least 1 nonresidential property
- Total taxable landholding < \$1m
- State Revenue Office to contact all who are eligible for this deferral

Working for Victoria Fund

- Displaced workers eligible to apply for different types of paid work
- Employers can also register their requirements for talent
- Positions for duration > 3mths

VIC Councils

City of Melbourne

- Business Grants
- Up to \$5k to help businesses invest in online and e-commerce capabilities
- Up to \$2k for training and professional development
- Up to \$10k for capital works projects to adapt to changing conditions

City of Yarra

- · Creative Business COVID-19 Grant
- Up to \$5k for creative businesses, including live music venues, commerical galleries, rehersal studios and sole trader creatives.
- Creative Community COVID-19 Grant
- Up to \$2k for creative individuals, including artist, musicians, performers, and producers
- Up to \$5k for creative organisations and community groups.

City of Boroondara

- · Council Financial Support
- Waiving food premises registration fees

- Deferred Payroll Tax until 31 July 2020
- Deferred dates 3 Aug 2020

Interest Free Loans

- Up to \$250k
- · 12 mths interest free

WA

WA Payroll Tax

- Threshold increased to \$1m from 1 July 2020
- Taxable wages < \$7.5m apply to defer monthly tax payments until 21 July 2020
- Taxable wages > \$1m and < \$4m grant of \$17.500

TAS Payroll Tax

- Taxable Wages < \$5m
- March, Aprill or May 2020 payment not required to lodge
- One year rebate for employers who pay payroll tax and employ new youth employees < 25 yrs old

Emergency Grants

- One off \$2,500 grant
- · Additional support \$15k grant
- Tasmanian small business employing < 20 FTE employees
- Only for businesses operating in certain industries

Business Continuity Grants

• One off grant of \$750 for small business to seek professional advice
